As the successor of MDGs, the 2030 Agenda of Sustainable Development was adopted by all member states of UN in September 2015, which is transformative agenda for sustainable development. The agenda has proposed 17 goals and 169 targets and they are integrated and indivisible, global in nature and universally applicable. SDGs National Network Nepal (SDGs *Network*) is a common platform of civil society Major Groups and Stakeholders, which has been coordinating the civil society process on the 2030 Agenda of Sustainable Development (SDGs) in Nepal. SDGs National Network has been mobilizing and encouraging the civil society Major Groups including youth, women, children, Dalits, Indigenous Peoples, PWDs etc. for their effective engagement in SDGs. This network is directly engaging with governments, parliaments, local authorities, UN Agencies, INGOs, think-tanks, media and other international agencies.

Objective

Main objective of the network is to contribute to achieving SDGs in the country by promoting engagement of civil society major groups and sustainable development advocates. So, the 2030 Agenda is the major working area of the network.

🎇 Membership

SDGs Network is a member based platform. There are three types of members under this network:

- Individual organizations
- Alliances, networks, coalitions and federations of CSOs
- Individuals

******* Principles

Human Rights and Development Justice are two major principles of the network.

Working territory

SDGs National Network Nepal works in the whole country and it has local chapters at province and district level. It can form its chapters at municipality level as well.

🌺 Key functions

Key functions of the SDGs National Network are:

- Working with government institutions including legislative and judiciary at all levels
- Working with formal processes of Governments, UN and IFIs at all levels
- Working with Major Groups and Stakeholders including academic society and institutions
- Working with international networks, alliances and platforms
- Working on oversight for accountability
- Working on communication and knowledge management

Governance

Guiding Document

SDGs National Network is governed by an Operation Guideline Document. It is the major policy document that guides the entire functions and activities of the network. The Operational Guideline ensures the works of network systematic, responsible, accountable and transparent.

National Coordination Committee

SDGs National Network Nepal has 9-member National Coordination Committee (NCC), which is formed to coordinate and facilitate functions of the network. Among them there are 7 elected organizations (at least 3 women) and 2 elected individuals (at least 1 women). The term of NCC is for two years. Among 9 organizations one organization plays a role of convener. Convener organization also provides secretariat service to the network. Election of NCC takes place through online voting system. Representatives in the NCC are nominated by respective organizations. For now, National Coordination Committee is comprised of following eight organizations.

- 1) Association of Youth Organizations Nepal (AYON)
- 2) Dalit Welfare Organization (DWO)
- 3) Dalit Youth Alliance (DYA)
- 4) National Campaign for Sustainable Development Nepal (NACASUD-Nepal)
- 5) National Farmers' Group Federation (NFGF)
- 6) National Indigenous Disabled Women Association Nepal (NIDWAN)
- 7) Nepal Disabled Women Association (NDWA)
- 8) Women for Human Rights Single Women Group (WHR)
- 9) Youth For Environment Education Development (YFEED)

Advisory Group

There is a provision of formation of 5-member advisor group (including at least 2 women). Term of advisory group is also for 2 years.

Convener Organization serves as secretariat

National Campaign for Sustainable Development Nepal (NACASUD-Nepal) is now contributing as the convener organization and it is providing secretariat service to the network by liaison, coordination and facilitation. NACASUD Nepal is the member of Regional Coordination Committee of Asia Pacific Regional CSOs Engagement Mechanism (AP-RCEM), which is directly engaging with UN-ESCAP at regional and sub-regional level. Similarly, province level convener organizations contribute as secretariat at province level.

🌺 Major Groups and Thematic Groups

Major Groups Thematic Areas

Major groups are the foundations of the SDGs National Network. Currently, there are 26 Major Groups under the network. They are (i) NGOs, (ii) Youth, (iii) Women and Girls, (iv) Children, (v) LGBTIQ, (vi) Migrant Workers, (vii) Scientific and Technological Community, (viii) Cooperatives, (ix) Workers and Trade Unions, (v) Indigenous Peoples, (xi) Dalits, (xii) Madhesi, (xiii) Farmers, (xiv) Senior Citizens, (xv) Muslims, (xvi) People Living with Disabilities (PWDs), (xvii) People Living with HIV and AIDS (PLWHA), (xviii) Local Authorities, (xix) People Affected by Conflict, (xx) academic society, (xxi) Micro-entrepreneurs, (xxii) micro-finance groups, (xxiii) CBOs, (xxiv) single women, (xxv) Landless and squatters, and (xxvi) People affected by natural disasters.
